BOUNDARIES OF AVALON MINOR HOCKEY ASSOCIATION, AND CELTICS MINOR HOCKEY ASSOCIATION ST. JOHN'S MINOR HOCKEY ASSOCIATION

In January 1986 the following boundaries were established by the three Minor Hockey Associations listed above and approved by the NAHA Minor Council:

Avalon - All boys attending schools administered by the Avalon Consolidated School Board residing within the city of St. John's and those boys residing outside the city of St. John's but who are not living within the boundaries of an active association and subject to C.A.H.A.

Ecole >+ Parnet & Ecole >+ General Amountains

Celtics - All boys attending (St. Patrick's Hall Schools, Λ Holy Cross Schools, St. Bonaventure's, St.Pius X and Brother Rice High) schools residing within the city of St. John's and those boys residing outside the city of St. John's but who are not living within the boundaries of an active Association and subject to all conditions relative to C.A.H.A. residential qualifications.

St. John's - All youth residing within that area enclosed by the dark line on the attached map, excepting those (1) who are attending schools administered by the Avalon Consolidated School Board, or (2) attending St. Patrick's Hall School, St. Bonaventure's College, Brother Rice, St. Pius X, or (3) any other youth living within the boundaries of another active Minor Hockey Association.

NOTWITHSTANDING the above, due to movement of players between these three associations due to school changes, it is agreed that effective for the 1996-97 season the following agreement is entered into by all three associations and approved by the NAHA by way of signing this document. Failure for all parties to agree to this agreement will result in this agreement becoming null and void and the 1986 boundaries will take precedence.

1996-97 BOUNDARY AGREEMENT

Due to the changes that have and will continue to occur to the educational structure in the province, specifically within the boundaries of the Avalon, Celtics and St. John's Minor Hockey Associations, and due to the disregard of certain parents and players toward the existing Minor hockey associations structure, policy and regulations in these boundaries, we the undersigned Minor Hockey Associations agree that all students wanting to participate in Minor Hockey in the existing boundaries of said associations will register with the association to which their school is designated. Up to age 10 (last year of novice) all players will continue to register with their original association unless they have relocated to another school that is designated with another Minor Hockey association. AFTER NOVICE AGE (GOING INTO ATOM LEVEL) ALL PLAYERS WILL REMAIN WITH THE ASSOCIATION TO WHICH THEY WERE REGISTERED IN THEIR LAST YEAR OF NOVICE.

NOTWITHSTANDING THE ABOVE, if there are extenuating circumstances surrounding a player's registration requirement, allowances may be permitted providing the request is in writing and written permission is obtained from the three Minor Hockey associations named in this agreement and the NAHA Minor Council chairperson. Such approval must be forwarded to the NAHA Secretary Treasurer prior such player's registration.

This agreement will remain in effect until such time a new written agreement is entered in to by the three Minor Hockey Associations named herein and approval has been obtained in writing by the NAHA Minor Council Chairperson and the President of the NAHA.

We the undersigned, enter into this agreement and we will not knowingly allow any player who is eligible to register with our association in accordance with this agreement to do so.
